



Classical Homeopathic Consultation Fee Schedule

Initial Consultation:	\$285 for adults (2-2.5 hours) \$235 for teens, 13-17 years (1.5-2 hours) \$185 for children, 0-12 years (1-1.5 hours)
Follow-up Consultation:	\$110 for adults (45 mins-1 hour) \$100 for teens and children (30-45 mins)

Please note that the time length of the appointment is approximate and timing varies according to the individual.

GST (if applicable) is not included in these prices

A 4% discount will be applied to *email money transfer, cheque or cash payments*

Clients will be invoiced after their appointment and payment will be due upon receipt. In addition to cash, email money transfer and cheque I also accept PayPal, Visa, Mastercard, American Express and Discover.

Included in the price:

- Full supply of your constitutional homeopathic remedy
- Brief 5-minute weekly check-ins by email or phone between paid consultations, to assess the effectiveness of your remedy

Not included in the price:

- Clients who need their remedy shipped to them will be invoiced the price of postage: \$5 for regular mail and \$10-\$22 for courier mail depending on their location.
- If the client wishes to purchase extra remedy bottles, in addition to their prescribed constitutional remedy, there is a fee of \$11 per remedy.

Follow-up Consultation Schedule

For the most effective treatment possible, I recommend that the first follow-up consultation be scheduled approximately 4 weeks following the initial consultation. The second follow-up should be scheduled approximately 6 weeks after the first follow-up consultation. Follow-ups thereafter should be scheduled every 1-3 months according to my recommendation. I will notify you by email and/or phone approximately 1-2 weeks before your next follow-up consultation is due, and your follow-up can be booked at that time.

Please note that when treating complex health conditions such as autism, ADHD, PANS/PANDAS, Lyme, multiple chemical sensitivities etc. more frequent follow-ups will usually be recommended for at least the first few months of treatment, every 2-4 weeks as needed. Frequency of recommended follow-ups varies from person to person and will be recommended at my discretion.

Extra Fees

Extra telephone questions, conversations or emails that extend beyond the 5-minute check-in time allowed in between consultations will be charged at the rate of \$60 per 30 minutes of my time.

Acute Consultations

\$52 includes a 15-20 minute consultation for acute health complaints (coughs, colds, flus, first aid, etc.). Recommended remedies can be purchased locally by the client, or purchased at the clinic for a fee of \$11 per remedy.

Cancellations and No-Shows

24 hours' notice must be given if you need to cancel or change your appointment, otherwise you will be charged a \$50 missed appointment fee.
